TERMS OF SERVICE

Effective Date: October 9, 2025

1. AGREEMENT TO TERMS

By accessing or using any Roaster service ("Platform", "we"), you ("User", "you") agree to be bound by these Terms of Service ("Terms"), the Roaster Privacy Policy, applicable laws and all other agreements and policies referenced herein. If you do not accept these Terms, you may not access or use the Platform.

2. SERVICE DESCRIPTION

Roaster is a Roast-to-Earn social engagement and gaming platform integrating X (Twitter) and blockchain networks to provide gamified social content, cryptocurrency rewards, sponsored campaigns, user-generated "roast" content and tokenized digital assets. The Platform evolves and expands, and all features/services are provided "AS IS" and "AS AVAILABLE."

3. USER ELIGIBILITY AND COMPLIANCE

- Minimum Age: 18+ (or age of majority in your jurisdiction, if greater); parental consent and supervision required for users aged 13-17 (where permitted).
- Jurisdictional Restrictions: You represent and warrant you are not in, residing
 in, or a national of any country or region embargoed or otherwise prohibited
 by local, national, or international laws or sanctions, and are not on any
 restricted party list (e.g., OFAC, EU Sanctions, UN, etc.).
- Account Integrity: Provide accurate, up-to-date information. You are solely responsible for all activities under your account and must report unauthorized use immediately.
- KYC/AML: Certain features (including, but not limited to, contests, token rewards, and high-value wallet integrations) may require enhanced KYC/AML checks. Refusal will result in loss of access to those features.

4. ACCEPTABLE USE AND CONTENT GUIDELINES

 Prohibitions: No use for unlawful activities, money laundering, market manipulation, harassment, infringement, discrimination, or encouraging/performing offensive behavior.

- Anti-cheating: Strict ban on bots, fake/fraudulent accounts, point-manipulation, collusion, algorithm exploitation, or abusing platform/game mechanics.
- Community Protections: Prohibition on harassment, doxxing, cyberbullying, obscene material, impersonation, or humor that crosses into hate or defamation. Roaster reserves final discretion on enforcement, including but not limited to warning, removal, or permanent ban.
- Fair Use & Transformative Humor: All "roast" content must respect copyright and trademark law and comply with Roaster's guidelines for transformative fair use.

5. INTELLECTUAL PROPERTY RIGHTS

- Platform, code, trademarks, trade dress, Roast Engine, and all proprietary technologies/content ("Roaster IP") are owned or licensed by Roaster. Users are granted limited, revocable, non-sublicensable licenses for personal use only.
- By uploading/posting content, users grant Roaster a nonexclusive, worldwide, royalty-free, sublicensable, perpetual license to use, publish, display, distribute, adapt, and create derivative works for any lawful purpose, including promotion and partnership campaigns.
- Users represent and warrant their content does not infringe any third-party rights and are solely responsible for legal risk.

6. TOKENS, DIGITAL ASSETS, AND BLOCKCHAIN OPERATIONS

- Token Features: Use, reward, or functionality of any digital assets are subject to change, and Roaster makes no representations as to their current or future value, utility, tax status, or regulatory treatment. No aspect of token distribution constitutes offering, solicitation, or promotion of securities or investment contracts.
- Wallet Security: Users are solely responsible for wallet private keys, security, and blockchain interactions. Transactions made on public blockchains are irreversible and cannot be undone by Roaster.
- Regulatory Compliance: All digital assets issued, distributed, or exchanged are subject to applicable securities laws, money transmission, or other regulation, as updated.

7. THIRD PARTY PARTNERS & INTEGRATIONS

Roaster may integrate, interact, or allow participation with external social networks, blockchain protocols, and service providers ("Third Parties"). Use of those features subjects you to those Third Party terms. Roaster disclaims liability for Third Party conduct or platforms.

8. DISCLAIMER OF WARRANTIES & LIMITATION OF LIABILITY

- Roaster is provided "AS IS" and "AS AVAILABLE". To the fullest extent
 permitted by law, no warranties of any kind, express or implied, as to reliability,
 safety, fitness for purpose, merchantability, or non-infringement.
- Blockchain Risk: Platform may be disrupted by cyberattack, blockchain forks, protocol bugs, regulatory change, denial-of-service, internet outages, or smart contract failure. Users accept all blockchain operational risk, including complete, partial, or time-limited loss of tokens and functionality.
- Liability Cap: In no event shall Roaster's aggregate liability to any user exceed USD \$100 or total fees paid by that user in the preceding 12 months, whichever is greater, regardless of theory or cause.
- No Consequential Damages: No liability for indirect, incidental, punitive, exemplary, or consequential damages.

9. INDEMNIFICATION

You agree to fully defend, indemnify, and hold harmless Roaster, its affiliates, officers, directors, agents, suppliers, partners, and licensors from and against all claims, actions, damages, losses, liabilities, costs (including but not limited to legal and professional fees) arising out of, relating to, or resulting from: (a) your access to, use of, or alleged use of the Platform; (b) your breach or alleged breach of these Terms, applicable law, or third party rights; (c) your content; and (d) any activity occurring through your account or wallet.

10. DISPUTES, GOVERNING LAW & ARBITRATION

- Jurisdiction: These Terms are governed by and construed in accordance with the laws of [PRIMARY JURISDICTION], without regard to its conflict of laws provisions.
- Arbitration: Except for injunctive relief, all disputes or claims arising from these Terms or Platform use will be resolved exclusively via binding arbitration under the most current commercial arbitration rules of [specified Arbitration Body] conducted in [Arbitration Seat], in English. Parties waive any right to trial by jury or participation in a class or representative action. Arbitration award is final and enforceable in any competent court.

- Time to Bring Claims: YOU MUST INITIATE ANY CLAIM WITHIN 1 YEAR AFTER THE CAUSE OF ACTION ARISES OR IT IS BARRED FOREVER.

Roaster may update these Terms at any time by notice, email, or posting on the Platform. Changes are binding on posting unless stated otherwise. Continued use after notice = acceptance. If you disagree, you must terminate your account and cease using all services immediately.

12. TERMINATION AND ACCOUNT DELETION

Roaster may suspend/terminate access with or without notice for any violation, fraud, abuse, or security threat. Upon termination, all rights/privileges end immediately, but all platform, IP, confidentiality, limitations of liability, and indemnification clauses survive.

13. GENERAL PROVISIONS

- No Class Action: All claims are to be brought on an individual basis, not as plaintiff or class member in any purported class or representative action or proceeding.
- Force Majeure: Roaster is not liable for any failure or delay due to acts beyond its reasonable control (natural disasters, government orders, etc.)
- Assignment: Roaster may assign, novate, or transfer rights to affiliates, acquirers, or successors at its sole discretion; users may not assign without written consent.
- No waiver: Failure to enforce a provision is not a waiver of future enforcement.
- Severability: If any provision is held invalid or unenforceable, remainder stays effective to fullest extent.
